TYLECO® 50 GRANULAR

FOR THE PREVENTION OF ILEITIS IN PIGS.
FOR REDUCED INCIDENCE OF LIVER ABSCESS IN CATTLE.

PRESENTATION: A light brown, free flowing granules.

ACTIVE CONSTITUENTS: Each kg contains: 50 g TYLOSIN (as tylosin phosphate)

PROPERTIES: TYLECO® 50 GRANULAR contains tylosin phosphate, a macrolide antibiotic which is a complex mixture of closely-related antibiotics, more effective against gram-positive than gram-negative micro-organisms. It is also active against mycoplasmas and some rickettsiae. It aids in prevention of ileitis in pigs and helps in reduction of the incidence of liver abscess in cattle.

TYLECO® 50 GRANULAR is relatively non-toxic following oral administration and has a wide margin of safety in all species.

DOSAGE AND ADMINISTRATION:

BEFORE USE, THOROUGHLY MIX TYLECO® 50 GRANULAR, ACCORDING TO THE RECOMMENDED DOSAGES DESCRIBED UNDER, "DOSAGES AND ADMINISTRATION" UP TO MAXIMUM PROPORTION OF 2.0 kg (2,000 grams) TYLECO® 50 GRANULAR TO 1 TONNE OF FINAL FEED:

PIGS:

TYLECO® 50 GRANULAR /tonne of feed	Tylosin equivalent /tonne of feed
800 g	40 g

Prevention of ileitis:

CATTLE:

Reduction in the incidence of liver abscess:

In complete feeds: 220 g TYLECO® 50 GRANULAR/tonne of feed (equivalent to 11 ppm* tylosin).

Supplementary feeds: 60 – 150 mg tylosin/animal/day. Calculated on total dry matter intake and supplementary feeding rate of animal. The level of tylosin should not exceed 11ppm of total dry matter intake (including supplement and other feed consumed per day). The following is an example (see label for details).

Supplementary Feeding Rate (kg/head/day)	Tyloco 50 Granular/tonne of feed	Tylosin equiv./tonne of feed
1	3 kg	150 g
3	1 kg	50 g
5	600 g	30 g

* ppm (parts per million) = mg/kg

Increase the level of TYLECO® 50 GRANULAR up to the required dose of tylosin over a period of 5 to 7 days. Dietary changes should be done gradually.

WITHHOLDING PERIOD: MEAT – NIL (at 100 g or less tylosin per tonne of final feed). MILK – NIL.
