DOSAGE & ADMINISTRATION:

VITAM® HEALTH & VITALITY™ should be provided daily to insure correct intake. For best results use in conjunction with CALCIPLEX BONE AND JOINT™. For individual use, mix with dry feed either morning or evening meal. One level scoop contains 30 g. Dose according to the following table:
